Congress Votes to Fund Government Until February 8th

Congress passed a short-term continuing resolution on January 22nd, which was signed by the President, to provide funding for government operations until February 8th. Congress has not yet approved annual budget appropriations for FY2018, which started October 1, 2017. The short-term funding mechanism, called a continuing resolution, continues funds at the level for the previous year until a final budget passes. Government operations should return to normal almost immediately.

Data Needed for Meeting on Higher Minimum Wage for Federal Contractors

Next week, America Outdoors Association representatives from around the country will be meeting with federal agencies and Congressional leaders on a variety of issues of importance to the outfitting industry. Among the issues include:

- An exemption for our industry from E.O. 13658, which requires a higher minimum wage for federal contractors, (See the request for information below);
- H.R. 2771, which restores the seasonal recreational establishment exemption in the Fair Labor Standards Act for outfitters;
- The GO Act, which will be introduced in the Senate this week. We will be seeking co-sponsors. The GO Act has already passed the U.S. House of Representatives.
- Exploring a short-haul exemption of 150 air-miles for 9 to 15 passenger vans under 26,000 lbs gross weight.
- Meeting with all the federal-land managing agencies on the issues and changes occurring at each, including their regulatory reform agenda.
- Infrastructure bill, which is supposed to have a big component for rural economies. We submitted input to Congers last year on possible projects that you sent to us.

What we need from you for a key meeting on the higher minimum wage for federal contractors:

We need stories and data about the impacts of E.O. 13658 on your business. We have some but need a few more. All the data will be anonymous. The minimum wage for 2018 for federal contractors and permit holders is \$10.35/hr and \$15.52 unless you are in a state with stricter standards, in which case the state standards apply.

Please supply this information to dbrown@americaoutdoors.org on or before noon eastern time on Thursday, January 25th on the impacts of this requirement on your business (now or in the future if it becomes applicable)

- Brief description of business and services (% of day trips/% in back country and general locations)
- Gross revenues.
- Number of full-time (more than 4 months per year) and number of seasonal employees.
- Impacts of compliance with higher minimum wage on your business and services, such as
 - Modification or elimination of services and business
 - % of price increase required to comply
 - Impact on number of employees and hours worked
 - Any other reflections.
